

In case of an overseas family maintenance procedure (issuing an insurance certificate).

When my Chinese parents come to Japan, I want them to get a checkup at the internal department in Japan!

I'm worried about my American father, who lives alone and isn't doing too well lately. When he comes to Japan, I'd like to go to the hospital with him.

Maybe my Thai son/daughter's disease will be cured if he/she gets medical treatment in Japan.

Do you, as a foreign worker in Japan, feel this way?

We perform overseas resident maintenance procedure (issue of an insurance certificate) as a specialty at our office.

In case of a relative with the chance to come to Japan, it may be possible for him/ her to get medical treatment for the same price as a Japanese resident if he/she meets the maintenance conditions of the social assessor.

※ As the procedure of overseas maintenance is a technical procedure, there will be an extra charge in addition to the rate on our site rate list.

Of course, we also offer maintenance procedures for those who have an address in Japan without a Japanese nationality.

It'll be an indispensable important matter to come under the following conditions:

※ The dependent should be the relative of the president, the official, or the employee who belongs to the company which has a social insurance.

※ The income of the person who undergoes the procedure for maintenance (the one who issues the insurance certificate) is less than 1,300,000 yen by annual income in Japanese yen. The one with the remittance (the person who transfers the money) should have, or should be able to transfer, a higher remittance than the dependent's income.
